**ADOPTION & DEFINITION OF A MAINTENANCE MANAGEMENT PLAN (MMP) IN
TERMS OF NEMA, 1998 (ACT 107 OF 1998) AND THE ENVIRONMENTAL IMPACT
REGULATIONS, 2014: UPDATED MMP FOR THE LAPPIESBAAI BEACH AND
ADJACENT AREA AT STILL BAY.**

Above mentioned refers:

Kindly take cognisance of **condition 14** as stipulated within the attached document as obtained from the Department of Environmental Affairs and Development Planning (DEA&DP). The said condition directs the municipality to inform all Interested and Affected Parties (I&APs) of the 'Notification and administration of appeal' process.

The condition read as follow:

*"14. The Proponent must within **14 (fourteen)** calendar days of the date of the decision give written notice to all the interested and affected parties and organs of state which were identified and engaged by the Hessequa Municipality during the public participation process (hereinafter "the I&APs). The notice must –*

14.1. *inform the I&APs of –*

(a) the outcome of the decision;

(b) the date of the decision; and

(c) the date of issue of the decision;

14.2. *inform the I&APs of the fact that an appeal may be lodged against the decision in terms of the National Environmental Management Act: National Appeal Regulations (GN R.993 of 8 December 2014; and*

14.3. *draw the attention of all I&APs to the manner in which they may access the decision.*

Approval was granted by the Minister of Environmental Affairs to Hessequa Municipality for an additional 14 days, from the 5th of September 2016, which coincides with the date that before mentioned approval was obtained, to comply with the condition.

As a result, Hessequa Municipality hereby informs all I&APs that the above mentioned maintenance management plan for the Lappiesbaai dunes was adopted and defined by DEA&DP on the 1st of July 2016, which is also the date that the decision was issued.

All I&APs should note that an appeal may be lodged against the decision in terms of the National Environmental Management Act: National Appeal Regulations (GN R.993 of 8 December 2014).
