#### PROCUREMENT PREFERENCE POINT SYSTEM:

Tenders will be evaluated and adjudicated in terms of the Preferential Procurement Policy Framework Act (Act 5 of 2000), The Preferential Procurement Regulations, 2011 and the Hessequa Municipality's Supply Chain Management Policy, for which 90 points will be allocated in respect of price and 10 points in respect of B-BBEE contribution

Tenders shall be evaluated in accordance to Method 2 of the CIDB tender evaluation methods.

#### Method 2 - **Functionality, price and preference**

The successful bidder will be required to fill in and sign a written Contract Form. The following conditions to bid exist:

(Failure to comply may result in your bid being disqualified)

1. This bid is subject to the general conditions of contract of 2015 (GCC) and, if applicable, any other special conditions of contract.
2. Relevant specifications (SPECS).

A valid original tax clearance certificate issued by the South African Revenue Service (SARS) and audited bank states of the last 3 years must be included with the bids. Any Bid other than those from "Exempted Micro Enterprises (EME'S)" must be accompanied by a valid BBBEE verification certificate or a certified copy thereof.

Enterprises with an annual revenue of less than R5 million must attach an "Exempted Micro Enterprise" certificate from a Registered Auditor, Accounting Officer or a SANAS accredited Verification Agency to be able to claim EME status.

Tenders must be registered with **CIDB in a CE Class of construction works** and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation or 25 (7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers will need a grading destination of **6CE or higher**. 5CE Potentially Emerging Enterprises who satisfy criteria stated in the Tender Data may submit Tender offers.

Late, incomplete or bids submitted by facsimile will not be accepted. Proof of submitting a bid will not be accepted as proof of the bid having been received. The Municipality is not obliged to accept the lowest or any bid submitted to it. The Municipality reserves the right to accept any bid in full or in part.
