

HESSEQUA MUNICIPALITY PUBLIC NOTICE: INVITATION TO REGISTER ON THE CENTRAL SUPPLIER DATABASE (CSD)

As per instruction in terms of National Treasury MFMA Circular No 81, from 01 July 2016 municipalities will be obliged to utilise the Central Supplier Database (CSD) as their official list of accredited prospective providers when procuring goods and services. This notice serves to invite all current and prospective providers to Hessequa Municipality, that it is currently utilising the CSD to update and register as an accredited prospective provider.

During the 2015 budget speech, the Minister of Finance announced the development and future use of the Central Supplier Database (CSD) as a means of simplifying the process of doing business with government. Therefore, the CSD will be the source of all supplier information for all organs of state. The objectives of the CSD are to reduce the exchange of compliance documents in paper form, eliminate multiple registrations with different organs of state, and ultimately reduce the cost for both business and government by enabling electronic registration and verification processes.

The CSD integrates with the South African Revenue Service (SARS) to verify tax clearance certificates and the Companies and Intellectual Property Commission (CIPC) for business registration and business ownership information. The CSD verifies supplier information with the register for tender defaulters and database of restricted suppliers

As the CSD is a self-service portal, prospective suppliers are hereby invited to self-register on the CSD website www.csd.gov.za.

Please Note that REGISTRATION IS COMPULSORY TO CONDUCT BUSINESS WITH HESSEQUA MUNICIPALITY. The database will be used to verify the accreditation of a supplier before quotations are obtained and award can be made.

HESSEQUA MUNISIPALITEIT PUBLIEKE KENNISGEWING: UITNODIGING OM TE REGISTREER OP DIE NASIONALE SENTRALE VERSKAFFERS DATABASIS (SVD)

Ingevolge die instruksie uitgereik kragtens Nasionale Tesourie MFMA Omsendskrywe No 81, sal Munisipaliteite vanaf 01 Julie 2016 verplig wees om die Sentrale Verskaffers Databases (SVD) te gebruik as hulle amptelike lys van geakkrediteerde voornemende verskaffers wanneer goedere en dienste aangekoop word. Hierdie kennisgewing dien om alle huidige en voornemende verskaffers aan Hessequa Munisipaliteit in kennis te stel dat die munisipaliteit van die SVD gebruik maak en om hulle inligting op te dateer of om te registreer op die SVD.

Gedurende die 2015 begrotingstoespraak, het die Minister van Finansies die ontwikkeling en toekomstige gebruik van die SVD aangekondig om die proses van handel dryf met die staat te vereenvoudig. Dus sal die SVD as die bron van alle verskaffer inligting dien vir staatsorgane. Die doelwitte van die SVD is om die ruil van nakomings dokumente in papier formaat te verminder, verskeie registrasies met verskillende staatsorgane te elimineer, en om uiteindelik die koste vir beide besighede en die regering te verminder deur elektroniese registrasie en verifikasie prosessese.

Die SVD integreer met die Suid Afrikaanse Inkomstediens (SAID) om belastinguitklarings sertifikate te verifieer, sowel as met die Maatskappye en Intellektuele Eiendom Kommissie (MIEK) vir die verifikasie van besigheid registrasie en besigheid eienaarskap inligting. Die SVD verifieer ook verskaffer informasie met die register van tender wanbetalers en die databasis van beperkte verskaffers.

Aangesien die SVD 'n self-diens portaal is, sal voornemende verskaffers hulle self moet registreer op die SVD webblad by www.csd.gov.za.

Neem asseblief kennis dat REGISTRASIE SAL VERPLIGTEND WEES OM BESIGHEID MET HESSEQUA MUNISIPALITEIT TE DOEN. Die databasis sal gebruik word om die akkreditasie van 'n verskaffer te verifieer voordat kwotasies bekom en toekennings gemaak kan word.
