The following conditions will apply to all quotations:

- Prices quoted must be firm, inclusive of VAT and where applicable for delivery to the address indicated below. The total amount of the quotation must also be clearly indicated;
- Please refrain from quoting on goods that are out of stock or not usually stocked by your company, or indicate on your quotation that this is the case and what the delivery period on those items will be;
- If your quotation is accepted, goods and/or services must be supplied and delivered to the below mentioned address, accompanied by your delivery note and invoice (if possible);
- Quotations must to be valid for a period of 30 days;
- The delivery period must be indicated.
- The closed quotation is subjected to the General Conditions of Contract as contained in MFMA Circular 25 of 2005 and the conditions contained in Hessequa Municipal SCM POS section 3.2.4.

- If a quotation is submitted for the goods; services or works requested, you the supplier accepts the conditions of this quotation and that the goods; services and works will be supplied or constructed as per this quotation.
- A formal order will be issued to the successful supplier that will be a written instruction to the supplier to supply; deliver or construct as per specifications contained in this quotation.

If your quotation does not comply with above stated conditions, your quotation will not be considered.

If you have not received a response from the Municipality within thirty (30) days after the closing date of the quotation, please regard your quotation as unsuccessful.

Quotations will be evaluated and adjudicated in terms of the Preferential Procurement Policy Framework Act (Act 5 of 2000), The Preferential Procurement Regulations, 2011 and the Hessequa Municipality's Supply Chain Management Policy, for which 80 points will be allocated in respect of price and 20 points in respect of B-BBEE contribution.

It is estimated that prospective suppliers should have a CIDB contractor grading of 1 GB or higher.

The Municipality reserves the right to withdraw any invitation for closed quotations and/or to re advertise or to reject any quotation or to accept a part of it. The Municipality does not bind itself to accepting the lowest quotation.

Any Prospective Service Provider must make sure that they are registered and are valid on the Database of Hessequa Municipality and/or on the Centralised Supplier Database (CSD) and that they are in possession of a Valid Tax Clearance Certificate.

DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT FOR DESIGNATED SECTORS

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

Before completing this declaration, bidders must study the General Conditions, Definitions, Directives applicable in respect of Local Content as prescribed in the Preferential Procurement Regulations, 2011 and the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:2011 (Edition 1) and the Guidance on the Calculation of Local Content together with the Local Content Declaration Templates [Annex C (Local Content Declaration: Summary Schedule), D (Imported Content Declaration: Supporting Schedule to Annex C) and E (Local Content Declaration: Supporting Schedule to Annex C)].

1. General Conditions

- 1.1. Preferential Procurement Regulations, 2011 (Regulation 9) makes provision for the promotion of local production and content.
- 1.2. Regulation 9.(1) prescribes that in the case of designated sectors, where in the award of bids local production and content is of critical importance, such bids must be advertised with the specific bidding condition that only locally produced goods, services or works or locally manufactured goods, with a stipulated minimum threshold for local production and content will be considered.
- 1.3. Where necessary, for bids referred to in paragraph 1.2 above, a two stage bidding process may be followed, where the first stage involves a minimum threshold for local production and content and the second stage price and B-BBEE.
- 1.4. A person awarded a contract in relation to a designated sector, may not sub-contract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 1.5. The local content (LC) expressed as a percentage of the bid price must be calculated in accordance with the SABS approved technical specification number SATS 1286: 2011 as follows:

$$LC = [1 - x / y] * 100$$

Where

x is the imported content in Rand

y is the bid price in Rand excluding value added tax (VAT)

Prices referred to in the determination of x must be converted to Rand (ZAR) by using the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid as required in paragraph 4.1 below.

1.6. A bid may be disqualified if –

- (a) this Declaration Certificate and the Annex C (Local Content Declaration: Summary Schedule) are not submitted as part of the bid documentation; and
- (b) the bidder fails to declare that the Local Content Declaration Templates (Annex C, D and E) have been audited and certified as correct.

2. Definitions

2.1. **“bid”** includes written price quotations, advertised competitive bids or proposals;

2.2. **“bid price”** price offered by the bidder, excluding value added tax (VAT);

2.3. **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;

2.4. **“designated sector”** means a sector, sub-sector or industry that has been designated by the Department of Trade and Industry in line with national development and industrial policies for local production, where only locally produced services, works or goods or locally manufactured goods meet the stipulated minimum threshold for local production and content;

2.5. **“duly sign”** means a Declaration Certificate for Local Content that has been signed by the Chief Financial Officer or other legally responsible person nominated in writing by the Chief Executive, or senior member / person with management responsibility (close corporation, partnership or individual).

2.6. **“imported content”** means that portion of the bid price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or its subcontractors) and which costs are inclusive of the costs abroad (this includes labour and intellectual property costs), plus freight and other direct importation costs, such as landing costs, dock duties, import duty, sales duty or other similar tax or duty at the South African port of entry;

2.7. **“local content”** means that portion of the bid price which is not included in the imported content, provided that local manufacture does take place;

2.8. **“stipulated minimum threshold”** means that portion of local production and content as determined by the Department of Trade and Industry; and

2.9. **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing another person to support such primary contractor in the execution of part of a project in terms of the contract.

SPECIFICATIONS FOR THE RESTORATION OF ROTTEN SECTIONS OF THATCHED ROOF AND THE REPLACEMENT OF SECTIONS OF THE THATCHED ROOF: ALBERTINIA LIBRARY

All work must be completed before, but no later than, 15th June 2017.

A penalty fee of 10% of the original starting price will be enforced on a daily basis (per day) if the work is not completed at the before mentioned date.

Only registered Thatch Contractors with at least 8 years thatch experience and with proven experience of similar work as indicated in the specifications below, will be considered. At least 3 references of completed similar work in the past 2 years must also be supplied.

A minimum guarantee of 15 years for workmanship and building materials installed and all related building works must be supplied in writing by the successful Contractor as part of his/her quotation.

The Contractor will also be held responsible for the appropriate cleaning up of the inside and outside of the library during and also after the work is finished before the final payment will be made.

Special care must be taken not to damage any aspects of the building such as water pipes, electrical works, the ceilings, etc. as any damages and replacements shall be for the account of the Contractor.

The successful Contractor must also supply his own temporary storage room/container for keeping and locking up all tools, building materials and accessories during such time it takes to complete the thatching project.

The quotation must include all related expenses, i.e. all new material, transport of material, labour and the removing of all refuse.

Only correct treated male thatching-reeds of excellent quality will be accepted.

SPECIFICATION OF WORK

1. Replacement of existing thatched roof on both sides of the gable at the main entrance of the library:

It must consist of:

Removal of the existing damaged sections of the thatched roof.

Supply of male thatching (Rooiriet) for replacement thatching and removal of rotten or weathered thatching.

Only galvanized wiring is permitted.

Installation of two Aluminium gutters must be done by the contractor.

All material, eg. string for thatching, fire blankets, Aluminium flashing,; DCP gun plast, chicken wire etc.) which are going to be used to complete the project, must be supplied by the contractor.

Gables must be sealed with waterproofing material where it joins up with the thatch, by the contractor.

2. Restoration of the rest of the existing thatched roof

Removal of the damaged and rotten sections of the thatched roof must be required.

The ends of rotten thatch must be cut off and weathered thatch must be removed. Damaged sections must be restored.

Gables must be sealed with waterproofing material where it joins up with the thatch, by the contractor.

3. Replacement of the existing cement ridge

Removal of the existing cement capping is required.

A layer of new male thatch must be joined into the roof.

A new cement capping must be installed.

The cement capping must be sealed with waterproofing material.

All material (eg. cement, sand, chicken wire, waterproofing material etc.), which are going to be used to complete the task, must be supplied by the contractor.
